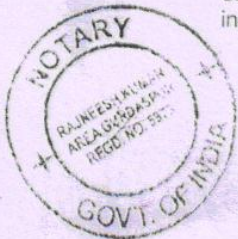
- 1) In case of any complaint/ inspection in future, if it comes to the knowledge that the application has been submitted with wrong information for getting N.O.C. or the instructions given by the Punjab Govt. from time to time are not adhered to or the undertaking given in the affidavits are not followed. Then the N.O.C. can be withdrawn.
- 2) The teaching of Punjabi up to X Class will be compulsory in your school and the C.B.S.E. New Delhi will make all arrangements of conducting Punjab Examination in such school, of its own level and if it is not done so, No Objection Certificate will be withdraw.
- 3) After getting affiliation with the C.B.S.E New Delhi, the school Management will be bound to pay salary and other allowances to its Teaching and Non - teaching staff as per Govt. employees. In case, this is not heaving done, The N.O.C will be withdrawn immediately.
- 4) You yourself and your school management will ensure that any information required by the D.E.O. of your Distt. Or by any other Senior Officer of the Punjab Education Department is provided for forthwith and full cooperation is extended.
